2025 Fall Membership Meeting

Department Commandant's Report

First, I would like to thank you for entrusting me to serve as your Department Commandant for another term. Before I get into the state of our Department, I'll briefly go over events since we last met at our Department Convention.

Since June of this year, I have attended the Mideast Division Conference in Virginia. There was not a lot of information provided, except for the new procedures for submitting Division MOY/AOY and updating the Mideast Division Conference guidelines for hosting an event. Unless immediate attention is given, all presentations of reports were waived. Frank Mathers was elected as the new Mideast Division National Vice Commandant, and Scott Kirby was elected as the new Mideast Division Assistant National Vice Commandant.

Afterwards, I attended the 2025 National Convention in Grapevine, Texas. I had the opportunity to attend the Medal of Honor banquet and listen to an amazing guest speaker. There were 48 National Bylaw and Administrative Procedures change requests. The new documents are available on the National website, as well as on the Department's website. Once the Department bylaws are approved by National, they will be placed on the website and emailed to the members. Two detachments also received National awards, for which I will present later today. Overall, it was a great convention, and it was great to see many of our fellow members from all across the country.

In addition, I have travelled the state, visiting detachments, swearing in newly appointed Department staff, and presenting awards to many deserving members like yourselves. To the Detachment Commandants who responded to my request, thank you. During my travels, I also visited the Carolina Museum of the Marine and got the 2026 Department Convention date set. Visited the Marines of Lima Company at the School of Infantry – East, and I will be talking about that visit more during the new business segment.

Overall, it has been a busy 6 months, and I look forward to visiting the rest of the detachments.

Now, I want to read an email I sent out on June 25th of this year, in case it was either not sent to the detachment membership or wasn't read. I challenge each of you to listen to what it says, then look at not only your detachments, but yourselves as well. Then ask, what are we doing not just in our communities, but within our own walls?

Subj: THE FUTURE OF THE DoNC MARINE CORPS LEAGUE

I would like to thank everyone for the confidence and support you have in me by allowing me to serve you for another year as the Department Commandant. It is a responsibility that I do not take lightly and with our team in place, will continue to move the Department forward. I also want to thank all of you for the outstanding work you are doing in your communities. Trust me when I say it is not going unnoticed.

There a few items that I want to address in order for the mission to continue pressing forward; 1) Detachments submitting their forms in a timely fashion, 2) The number of unpaid members, 3) Department leadership – both elected and appointed, 4) Where do we go from here.

Detachment leadership needs to focus on getting their forms turned in. This is their ROI's, Notice of Death, 990's, etc. These forms are vitally important to keep each detachment in compliance with all entities. I have pulled the department compliance report from Atlas, and I was shocked to see the number of detachments that have not even submitted an ROI for nearly 5 years. Failure to properly submit those forms can put your detachment at risk of charter suspension. Please get them submitted to Assistant Paymaster Colin Mayo, Adjutant Justine Mitchell, and your District Vice-Commandant.

Currently, we have over two hundred unpaid members across the Department. This does not include the number of members that have been dropped from your rosters. It is the responsibility of detachment leadership to ensure that your members are current in their annual dues. When you install elected or appointed officers in your detachment, one of the questions asked by the Installing Officer is have all dues been paid and forwarded to the proper channels. I have been advised that there are members now holding officer positions

that have not paid their dues. That puts the detachment out of good standing. If those members are current, then the Paymaster needs to contact Colin and find out what happened. If you have unpaid members, find out why they have not paid. Recruitment is important, but retention is vital. What are you doing to keep members in your detachments?

All Department staff represent the members of the Department of North Carolina. Elected staff, the members entrusted us to move the Department forward. The last election was a revelation for me. Granted, we are not going to please everyone, no matter how much we are doing. However, despite my beliefs, I noticed those results that many of our members were not pleased with how the department was lead. I know what started all of that and it began with our Fall Membership meeting when Tropical Storm Helene spread her poison across Western North Carolina. There were members that did not feel valued when they were not recognized for their efforts. I totally understand that, however, the members that were recognized were the ones that came across my email by detachment leadership for recognition. I do not have a problem with recognizing outstanding work, I just need to know who to recognize and why. Appointed staff, you have been asked to lead in the capacity you are currently in. I am going to hold each one of you accountable to your position, especially the District Vice-Commandants (DVC). We are going to hold virtual meetings to go over what is happening across the department. You are my eyes and ears to ensure that we are all in compliance. We have detachments that have no idea what is going on and that is unacceptable. Our job as Department staff is to assist, guide, and support our detachments.

Without our detachments, we have no reason to exist. For the DVC's that are supporting the mission, I thank you. Keep up the magnificent work.

Where do we go from here? The biggest challenge we have is the separation between the detachments and department. In my first year as Department Commandant, I was determined to mend that bridge. I thought we were moving in a positive direction, and I still think we have made tremendous strides. Our last two meetings were proof of that when we had attendance numbers that exceeded previous events. There were changes in our meetings that needed to be changed. That was no longer allowing members to blurt out mistakes being made by elected staff and members, creating disturbances during various segments of our meetings. Not only does that slow our meeting down, but it also causes members, especially new members, to question why they attended. It is okay to disagree and have conversation, but to create a disturbance or single out individuals will no longer be tolerated. I have even been accused of not giving our members a voice and controlling our detachments. For the detachments that I have visited, you know that is false. The only thing I look for when I arrive is three things required to hold meetings:

American Flag, Bible, and Charter. It is your detachment, you run it. This animosity has caused friendships to dissolve, uncalled for rumors being spread, and a sense of anxiety at our meetings. We are

a team and need to work together as such. Instead of sitting back in the shadows criticizing what is being done, try stepping up and assist. It says that during the installation of officers: Do not sit back and let the staff do it all. We were also taught in the Corps is to be part of the solution and not the problem.

Finally, we are moving forward into the digital age. That is happening across society, and we need to adapt accordingly. Yes, I understand some of you are not happy with that, but it needs to happen to run things fluently and effectively. That was proven when the Assistant Paymaster position was created. We will be scheduling a Leadership Training Academy shortly after the National Convention. At that academy, we will be training on every form and the responsibilities of every position within the Marine Corps League. Further information is forthcoming.

Subject: DoNC Judge Advocate Report for Quarter Ending 31 August 2025

I can proudly say that there have been no instances of grievances or disciplinary charges filed during this quarter.

We were remis in completing the annual review for department dues, and as such, there will be no change at this time. We did not complete the required department audit for reporting at the 2025 DoNC Convention and that was not completed until 6 September 2025.

As Judge Advocate it is my responsibility to ensure that we as a department adhere to all National and Department regulations, IRS, Federal, and State of North Carolina laws, rules and regulations applicable to us as a nonprofit organization. In review of our published guidelines, we have areas where guidance is lacking and/or nonexistent that are germane to our Marine Corps League mission. In particular, we do not have guidance established for handling of humanitarian and disaster relief aid, detailed procedures as to how donations and their related support should be handled, the use of credit/debit cards by members of the Department elected or appointed staff and the level of detail to which audits must be conducted to remain IRS compliant to ensure total transparency to the public.

We sometimes do things we believe to be the right thing but fail to realize that we have omitted critical points in the process. Hurricane Helene brought out the good in our organization and showed how fast we can respond to help in a disaster. Detachments, individuals, departments, and divisions from across the nation began pitching in as soon as the news was broadcast. Although we had no written policy at the time, people took action and began assembling whatever they could get their hands on to what they could to contribute to those in need. This was described as an emergency situation. In emergencies we sometimes bend the rules to do whatever is needed if the cause seems righteous. At the same time, we have to make sure that the things we do are in keeping with our responsibilities as nonprofits to account for our actions and that we have an audit trail to justify the actions we take. Key areas that were ignored are the coordination and dissemination of the planned actions taken in providing assistance to the Western North Carolina. The decision-making process for the department is embodied in its board of trustees, its elected officials and not simply one person. It has now been a year since Hurricane Helene did its devastation and now, we are still holding about \$12K that was donated for that support – we have take action as there will be need there for some time. The best help is always TIMELY.

Because our DoNC Bylaws do not presently contain instructions and restrictions on how donations are handled, authority for use of credit/debit cards, details for audit of the Departments financial and property records, etc., I have already begun re-writing appropriate sections of those areas where clarity must be provided. I will submit each proposed change so that they can be posted to the DoNC website to give everyone a chance to digest their impact and importance before they are voted on at the 2026 Convention. Those that are operational in nature can be approved by the Executive Board of Trustees and put in place immediately, if approved. Anything approved this way would require a 2/3 majority member vote at the 2026 Convention to repeal.

I believe we need to establish a Humanitarian and Disaster Relief Committee comprised of members from not less than three regions and ideally from all districts to collectively work to support through vetting the need of our detachments, communities and individual Marines and their families when a simple requirement arises, yet alone a serious disaster as we have experienced in the past few years. Whenever a need arises in their respective area, the members will immediately inform the Executive Board of Trustees so that appropriate actions can be taken. This doesn't mean that in a disaster situation that members can't begin assembling items for in-kind donations to be delivered to the needy, but in situations where funds are to be donated, that the closest HDRFC members can quickly identify the best suited organizations to work with to vet and facilitate the best use of the funds. We need to be conduit in these situations not the banker having to come up with ideas when there are established organizations that do this routinely.

Now that we have established a department level foundation that is a <u>501</u> C (3) non-profit, we need to ensure that such efforts as support for disaster relief and humanitarian aid are part of their make-up and they can and will be responsible for the accountability that the IRS and states require in handling donations.

During this past quarter I updated our Department Bylaws as approved by the membership at the 2025 DoNC Convention as well as those NBL/NAP applicable ones approved at the 2025 National Conventions. For those passed at National we can incorporate any such changes that can be mirrored and applied similarly at the Department level without member referral as a result of changes we approved at the 2024 Department Convention.

The Bylaws are a living document that require continuous update and revision/amendment, you are reminded that the deadline for submission of proposed changes to the National Bylaws and National Administrative Procedures (NBL/NAP) is 1 April 2026. The 2026 Proposed DoNC Bylaws changes are due to the DoNC Bylaws Committee and/or Department Judge Advocate NLY sixty (60) days prior to the start of the 2026 Department Convention (which has not yet been established)

They must be in the proper format and be addressed to the National Executive Director/Chief Operating Officer (NED/COO) See NAP Chapter Ten Section 10020 for specific information/instruction. Submission can be sent via Email, Certified U.S. Mail, or by other carriers where certified delivery may be verified, and a return receipt may be requested. If the proposal is mailed, it is recommended that a PDF of the source document be emailed to the NED/COO. Additionally, the source document (MS Word, WordPerfect, etc.) shall be emailed to the NED/COO. Receipt of the email submission(s) will be acknowledged by the NED/COO.

With a few exceptions, you all need to be looking into revising your own detachment bylaws. Most have not been updated in five years or more. I did a search on the changes approved at National conventions since 2020 and found that there have been 116 amendments to the NAP, and 26 amendments to the NBL. Granted a large number are at the National level but enough of those impact both the department and detachments that they should be read for content and then compared to the verbiage you presently have in place. I will also address this in the Compliance Officer report/

If you have not submitted a proposed change before and would like to have yours reviewed prior to actual submission, I will be glad to take a look at them as long as you don't wait to the last minute to do so.

Subject: DoNC Compliance Officer Report for Quarter Ending 31 August 2025

I have begun compiling information from existing files, the most recent submission of ROIs, PLM audits, and IRS 990 reporting by the detachments. We have not pushed the compliance reporting as we did in the past and I am trying to make it more accessible so that we can assist the detachments, working with the DoNC Assistant Paymaster and respective district vice commandants.

I have created a Compliance/Bylaws Status spreadsheet with tabs for both the Bylaws Status and the Compliance report based on what is required to be reported to the Division annually. As I also reported as the Judge Advocate, we are in serious need of updating the detachment bylaws. All but a small percentage have not been updated since 2020 or prior. I did a search of the NBL/NAP of changes approved at National conventions since 2020 and found that there have been 116 amendments to the NAP, and 26 amendments to the NBL. Granted a large number are at the National level but enough of those impact both the department and detachments compared to the verbiage you presently have in place.

Three of the most crucial elements of compliance reporting are:

submission of the annual IRS 990, 990 EZ or 990-N to make sure you remain as a nonprofit, (see NAP Section 8000); If you fail to submit your IRS 990 (most submit 990-N with annual revenues of less that \$50K) for three years you lose your nonprofit status and it requires some effort to get it back.

certification of Life Members (PLM Audit) which validates your entitlement to benefits earned by <u>von</u> detachment life members (see NAP 7050 and 7055). No funds from the interest on the life member fund will be distributed to a detachment unless the certified listing is received at National Office by the deadline. If a detachment fails to submit the annual Eligible Life Member Audit by the deadline, that detachment's share of the interest distribution shall remain in the Life Member Blocked Fund – at National

the Report of Officer Installation – Detachment forms (ROIs). If you fail to complete and submit the ROI to arrive at the National Headquarters by 30 June annually, <u>you</u> detachment is "NOT IN GOOD STANDING" and such detachment and its officers will not be recognized on the floor of the National Convention per NAP Section 6025.

As soon as I complete reconciling my data for the Compliance/Bylaws Status spreadsheet with the Assistant Paymaster and the most recent DoNC Quick Reference will be posted on the DoNC website. I would like to begin working on a training module for both the compliance reporting and the bylaws updates.

I am willing to arrange meetings online to go through any of your reporting requirements and actually update where needed to bring your detachment into compliance.
